

Caleb Sickbert wins USA Track and Field Indiana State and Regional Junior Olympic Championship in shot put and discus

The 2022 USA Track and Field (USATF) Indiana Association Junior Olympic Championships were held June 18-19 at North Manchester University's track at Spartan Stadium. This USATF event showcases the best youth athletes in the state and is a precursor to the USATF Regional Junior Olympic Track and Field Championships held July 9-10 in Crawfordsville at Wabash College's track at Little Giant Stadium.

The top athletes qualify for the USATF National Junior Olympic Track and Field Championships. Competition takes place in six two-year age divisions, with athletes falling between the ages of 7 and 18.

Caleb Sickbert, son of Aaron and Lindsey Sickbert of Ferdinand, competed in the Boys Shot Put and Discus Age 11-12 Division.

He captured the state title in shot put with a toss of 30 ft., 1.75 inches, and followed that up with the shot put regional title by earning a new personal record throw of 32 ft., 11.75 inches.

Caleb also claimed gold in the discus with a state title toss of 80 ft., 2.25 inches and followed that with a new personal record throw of 85 ft., 6.75 inches.

Caleb has qualified for the USATF National Junior Olympic Track and Field Championship in Sacramento, California this month.
